Abundance of Space

With Granite Exchange being a new flexible working space in Newry, our building shall provide a reduced level of occupancy in the current environment from the outset. We have 375 sq.ft of space including two kitchens and three toilets throughout the building. This provides us the unique ability to space members out across our building and over two floors.

Air Quality

Our state-of-the-art building guarantees 100% filtered fresh air to every office. We have no recycled air in out ventilation systems. We will also be carrying out frequent servicing of all our air conditioning units.


Remote-First

Social distancing

- Our reception, communal spaces and our meeting rooms have be reconfigured to allow for safe capacity levels and social distancing protocols
- Members will be encouraged to use our bike parking and showers as an alternative to public transport

Clear Desk Policy

To allow our cleaning team to sanitise your desk daily:

• We're introducing a clear desk policy. Members will be asked to ensure your desk is clear at the end of each day and all non essential items (everything other than screens and working equipment) are stored in your pedestals and cabinets.

Touch Points

We are installing automatic dispensers with hand sanitiser in all high traffic frequently used touch areas. You will find these at the entrance and throughout the building. Please use those as often as needed.





Risk Assessment

We have conducted a full Health and Safety Risk Assessment prior to opening in line with the Government guidance (which members can request). We encourage all our member companies to carry out their respective Risk Assessments within their individual private offices and submit risk assessments to management.
